## 4) Open issues

- a) Town of Farragut easement purchase offer regarding Virtue Road widening
  - i) January 3, 2020 Tim met with Darrell Smith, Town Of Farragut Engineer. TOF still does not agree with request to replace the concrete sidewalk along Virtue Road that is proposed to be torn up in connection with the Virtue Road widening. TOF proposes to replace the existing concrete sidewalk with an asphalt walkway, regardless of the SHA BOD opposition. No response was received from TOF as of today.
  - ii) Since the subject concrete sidewalk is within the TOF Right of Way (ROW) the SHA cannot compel TOF to replace the existing concrete sidewalk with another sidewalk

rather than an asphalt walkway. Rather the SHA BOD discussed the issue at the January 11, 2020 SHA annual meeting and posted a notice on the Sugarwood Facebook webpage and in the SHA Newsletter to advise the SHA residents should they want to voice their concerns/opinions to the TOF.

- iii) Suspicious cable running across Big Tree will be checked out by Chet
- b) Sugarwood Greenway maintenance
  - During Tim's January 3<sup>rd</sup> meeting, Tim reminded Darryl Smith, TOF Engineer of the state of disrepair of the Sugarwood Greenway; the asphalt walkway cracks present hazard to pedestrians.
  - ii) Tim also mentioned his finding of a pick-up truck driven down the steep asphalt Greenway from NHC and parked on the Greenway by a couple men taking a smoke break from working at NHC. Tim requested that the TOF install bollards in asphalt Greenway near the NHC drive to prevent reoccurrence of vehicular travel on the Greenway.
- c) Replace aging cypresses at Recreation Area; Chet
  - i) Southern Designs estimate \$530-\$4,144 too much; \$1,500 budgeted for 2020
- d) Pool resurfacing: Re the proposed 2020 budgeted pool resurfacing at \$50K estimated cost, Paul received the following bids. Decision of which bid to accept was deferred to the 2020 SHA BOD. \$43,000 Delgado Pool Plaster has been selected as the winner of contract for resurfacing the pool
