If 24 people are in the water we need a second lifeguard. Lifeguards to start calling at 20 people in the water.

Maintain a ledger with name, first and last of all people, number of people, time of entry.

2 hour limit, if pool is at its limit.

Make a waiting list with estimated time of your size family available.

Maintain a private ledger with names of those with temperatures of 100.4 or greater. They will not be allowed to enter the pool complex for 48 hours and upon a temperature recheck.

Who are the safety protocol people going to be? So far we have 2, possibly 3. We need at least 4. Required to be 21 years or older, able to tactfully handle confrontational situations.
