YOU ASKED ...


Recreation Area use during off-season

- Resident user reserves spot with Heather La Charite and submits payment and form
- ➤ Board member will unlock facilities prior to reserved party
- ➤ HOA provides cleaning supplies for residents under the sink
- Resident user is responsible for cleaning the facility after use, including sweeping, cleaning tables and countertops, putting trash in the cans by the tennis court bathrooms, replacing trash can liners, cleaning the grill if used and making sure the fire is extinguished in the fire pit and cover is placed back on it
- Facility will be inspected and relocked after event. If cleaning is adequate, deposit will be returned to resident


