Call to Order: The Sugarwood 2012 Annual Meeting was held on Saturday, January 14, 2012 at St. Elizabeth's.

Nomination of Board Candidates: President Ter Hark introduced the Board incumbents and nominees for the 2012 ballot. It was noted that Jim Hicks requested to be removed from the list of candidates. Nominations were sought from the floor. Nominees included Constantin Ceausu, Dave Freeman, and Tina Lawson Smith. It was moved by Dot Lamarche and seconded by John Frazier to close the nominations. Each nominee spoke and took questions from the floor.

Treasurers Report: Treasurer Conway reviewed the final 2011 expenditures and it was approved as presented. Treasurer Conway reviewed the 2012 budget that was mailed to all residents prior to the annual meeting. 2012 was approved as presented with an annual fee of \$290.00.

Swimming Pool: There is a new contract in place with the Stingray Swim team. No major pool expenses expected for 2012.

Social Activities: There was very good attendance for all activities in 2011, especially the Easter Egg Hunt and Fall Festival.

Installation of Street Lights: Dan Sparks gave an update on the revised Town of Farragut policies for streetlights. A motion was made by Scott Milken and seconded by Karen Hart to vote to approve an expenditure of up to \$5,000 in 2012 for additional streetlights. Use "bright pink" ballot C to vote on this item. Votes in favor were 30, votes opposed 30.

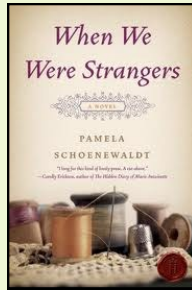

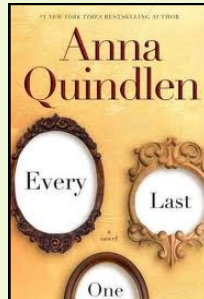
