





SHA Board of Directors Highlights from the 2013 Annual Meeting

Actual minutes to be posted on the SHA website: www.sugarwood.org. Held at St. Elizabeth Church, Tharp Hall—January 12, 2013

The annual meeting of the Sugarwood Homeowners Association was called to order at 10:00 A. M. by Martin Cumpston, President. Forty-one (41) homeowners attended the meeting in person and twenty-six (26) homeowners submitted properly documented proxies. With a total of sixty-seven (67) homeowners attending in person or by proxy, a quorum was present and the meeting was opened.

Board members were introduced:

Martin Cumpston, President Constantin Ceausu
Sue Conway, Treasurer Paul Hester
David Freeman, Vice President Ron Williams

The Nominating Committee's supported four candidates for a two year term on the Board of Directors. Candidate Bios were submitted to the membership in December. Nominations from the floor were opened. No candidates were nominated from the floor and nominations were closed. Martin Cumpston called for a vote on the Board Candidates. Ballots were collected and submitted to the tabulators.

- <u>Treasurer Report</u>: Sue Conway, Treasurer, presented a report detailing the financial condition of the association, the 2012 actual results, the 2013 budget, and 2013 proposed membership fee. The annual membership fee was proposed to be \$290 per year, the same amount as the past two years. Report was approved and membership fee was passed. With a motion made and seconded, Martin Cumpston called for a vote on the budget and proposed membership fee. The ballots were collected and submitted to the tabulators.
- Non-Smoking in Pool Area: A motion was made and seconded to make the recreational area's pool deck a non-smoking area. The ballots were collected and submitted to the tabulators.
- <u>Multi-Purpose Recreational Pad</u>: Ron Williams presented detailed description of proposed multi-purpose pad for recreation area. Scott Gibson motioned to approve the \$16,000.00 proposed budget for the multi-purpose pad. Motion was seconded. Valerie Thompson proposed a 10%-15% overrun to the proposed budget for cost overrun. Motion was amended, seconded, and passed by voice vote. The ballots on the amended motion were collected and sent to the tabulators.
- Liens: The board discussed the fact that approximately 249 of 264 members had paid the 2012 membership fees in full. Approximately 15 residences did not pay their 2012 dues. The amended covenants authorize the Board to take actions to collect fees. The covenants permit liens to be filed on those homeowners that purchased a home after the effective date of the amended covenants. Additionally, the Board may take legal and collection action on those members that signed the amended covenants. Scott Gibson made a motion to have the Board take legal action including filing liens on those residents that have acquired homes after the effective date of the amended covenants and to take collection efforts on those that signed the covenants. The motion was seconded by David Brenner. The ballots were collected and submitted to the tabulators.

• Ballot Item Results

- ◆ The 2013 budget and proposed membership fee of \$290.00 passed 66 for and 1 against.
- The motion to make the pool deck a non-smoking area passed 66 for and 1 against.
- ♦ The motion to approve the recreational multi-purpose pad passed 55 for and 5 against.
- ♦ The motion to authorizing the Board to file liens if a resident that acquired a home after the effective date of the amended covenants and to take legal action if economically sound on residents that signed the amended covenants passed 54 for and 10 against.
